Employer shall contribute \$1.00 per apprentice hour to the Apprenticeship & Training Fund for Apprentice Engineers indentured after January 1, 1984.

*The Defense Fund, Apprenticeship/PAC Fund, Apprenticeship Fund, Building Fund, Scholarship Fund, Social Fund, Building Trades Fund and United Way shall be combined for a contribution rate of **sixty-five cents (\$0.65) effective 01-01-2023, seventy cents (\$0.70) effective 01-01-2024**, per hour paid for to the Miscellaneous Employee Deduction Account. The deductions for 2026 will be allocated at a later date.
