Employer shall contribute \$1.00 per apprentice hour to the Apprenticeship & Training Fund for Apprentice Engineers indentured after January 1, 1984.

\*The Defense/Social Funds, the Apprenticeship/PAC Fund, the Apprenticeship Fund, the Building Fund, the Scholarship Fund, the Building Trades and the United Way shall be combined for a total contribution rate of **ninety-eight cents (\$0.98) effective 01-01-2023; one dollar and three cents (\$1.03) effective 01-01-2024; and one dollar and eight cents (\$1.08) effective 01-01-2025**, per hour paid for to the Miscellaneous Employee Deduction Account. The allocations for year 2026 will be done at a later date.
